Governor DeWine recently signed Amended Substitute House Bill 197 into law. This new law is a response to the health risks associated with the Coronavirus outbreak. Among other things, this new law allows public bodies such as boards of education to conduct their meetings using telephone conference, video conference, or other similar technologies. This law became effective on March 27, 2020. The Riverside Board of Education is committed to the health, safety, and welfare of our students and their parents, our staff, and our community in general. But even in these times, the Board needs to take certain actions to keep the district operational now and fully functional in the future. For these reasons, the Board will forego an in-person meeting tonight to avoid a gathering of our community members, will conduct this meeting by video conference, and will live-stream this video conference meeting to the public in accordance with this new law.

We ask all public viewers to disable their camera and mute their microphone during the meeting except for the designated public participation section on the agenda.
