July 28, 2020 Meeting

Minutes from the June 30, July 15, and July 17, 2020 meetings were approved.

The following **Finance/Audit** recommendations were approved:

- ❖ Monthly financial reports and check payment register report for June 2020 were approved.
- ❖ Approval for the waiver of the online payment service fee for electronic check (eCheck) payments made through Infinite Campus. The \$2.49 service fee for credit card payments will remain.
- ❖ Approval authorizing the treasurer to prorate the \$900 annual preschool fee based on the actual number of months of instruction during the 2020-2021 school year.
- ❖ Approval of grant applications and awards.
