Dear Parents of students attending the Chicago trip,

In an effort to keep with the ever-changing world of technology, LaMuth Middle School has developed a cell phone policy for the 7th Grade Chicago Trip as below:

• Students will be permitted to bring cell phones on the trip as a means to contact their parents while they are at the hotel. We are asking that students return the cell phone permission form with both student and parent signature on it. In addition, we are also asking for the phone number to be provided to set up a student contact list using the Alert Now system. Students without a signed permission form will have their phone confiscated for the remainder of the trip.

Student cell phone use is limited to authorized use which includes (receive messages via Remind system, contact parents, listen to music during non-educational experiences, take pictures of sights, etc.)

Phones and other technology may not be used (except for photography) while students are participating in any of the educational experiences offered on the trip.

• Students who use their phones/technology at inappropriate times or to send inappropriate/harassing messages will have the phone confiscated for the remainder of the trip. Inappropriate messages sent from a student's phone will be assumed to have been sent by the owner regardless of who actually sent the message. Parents will be contacted and the student is subject to any applicable school discipline.

• Students in possession of a cell phone without a signed permission form will be considered to be in violation of the 7th Grade Chicago Trip cell phone policy.

• Cell phones and other portable technologies are the sole responsibility of the student. The school is not responsible for lost, damaged, or stolen items throughout the trip. This includes any loss or damage incurred to a cell phone that has been confiscated due to violation of this policy.

• Students using their phone/technology devices to take and/or send inappropriate pictures while on the trip will be subject to strict school discipline and immediately sent home at the expense of the parents. The phone will be confiscated and authorities will be notified. "Sexting;" the act of sending sexually explicit messages (of themselves or others) or photos electronically, primarily between mobile phones, is a felony offense and will be treated as such by the LaMuth chaperones and administration.
